**Selection Procedure and Eligibility Criteria**  
**Chief Minister Green Fellowship Programme - 2024**  
**Pollution Control Board, Assam**

## 1. Selection Procedure

**Stage I:** Inviting Online Application from the aspirant candidates recommended by the Head of the Institution (College / University). A maximum of 5 (five) candidates shall be recommended by Head of the each Institution as eligible based on stated Eligibility Criteria.

**Stage II:** Short listing of applications received to 1:3 ratio based on the credit score on educational and preferred qualifications and other criteria.

**Stage III:** Final selection shall be made by the Board considering all criteria and personal interview.

## 2. Eligibility Criteria

**2.1 Nationality:** Indian (Identity proof is essential)

**2.2 Residential Identity:** Must be a permanent resident of Assam with domicile period as governed by law (Certificate or other Residential Identity proof from concerned authority is essential)

**2.3 Age:** Minimum 19 years and Maximum 22 years (Proof of age)

**2.4 Identity Proof:** Passport (mandatory) and any one photo identity proof as approved by Government of India.

**2.5 Address Proof:** Aadhaar Card (mandatory)

### 2.6 Educational Qualification

**Undergraduate (UG):** Studying in 3<sup>rd</sup> Semester onward in –

(i) B. Tech / BE in Civil, Chemical, Mechanical and Environmental Engineering with minimum aggregate score of 70% or an equivalent CGPA.

(ii) B. Sc with major in Chemistry, Life Science and Environmental Science with minimum aggregate score of 70% or an equivalent CGPA.

## **2.7 Physical Fitness and Moral Conduct**

The nominated students shall have – (i) High Physical Fitness and (ii) Good Moral Conduct. (i. Certificate from Registered Physician, ii. Certificate from respective College/University is essential)

## **2.8 Preferred Qualification**

- a) **Experience:** Experience of working or participation in any research project or exhibition pertaining to Environmental Management, Environmental Pollution Monitoring and Management, Forestry and Wildlife etc.
- b) **Communication Skills:** Good speaking and writing skills in local language and in English.
- c) **Leadership Skills:** Proven leadership skills at College / University level.
- d) **Problem Solving Skills:** Data Analysis, Visualisation and Problem Solving skills.
- e) **Extra-curricular Skills:** Extra-curricular skills in any domain.
