NOTICE

In pursuance of the OM No. E-647158/14, Dept. of Secondary Education, Govt. of Assam, dtd. 08.06.2025 the already constituted District Level Committee for Conducting Internal Examination of Class XI & XII (DLCCIE), Sribhumi had held a meeting on 24-10-2025 at the Chamber of the Inspector of School, SDC, Sribhumi resolved to conduct the Revision Test-2026 for H.S. 2nd Year (Class XII) in the first week of January 2026 as per ASSEB DIV – II schedule in all the Colleges / Higher Secondary Schools / Sr. Secondary School of Sribhumi district under affiliation of ASSEB DIV-II. For that purpose, Institutions are to collect Rupees 150/- as Examination Fees from each student for the Revision Test-2026 of H.S. 2nd year. Out of Rs. 150/-, Institutions are to deposit Rs. 68/- [Rs.65/- (to DLCCIE, Sribhumi for printing of question papers) + Rs. 3/- (to be paid by DLCCIE to the centre Institutions for monitoring the examination and arrangement of distribution of question papers)] to the DLCCIE. The fees of Rs. 150/- will be spend as per the following break-up:

- a. Rs. 65 /- per student to be spent by the Committee (DLCCIE) in printing of Question papers.
- b. Rs. 35 /- per student to be spent by the Institution for purchasing Blank Scripts.
- c. Rs. 20 /- per student to be spent by the Institution for purchasing other relevant materials, online entry & verification of marks and other administrative costs.
- d. Rs. 20 /- per student for evaluation of answer scripts.
- e. Rs. 10 /- (Rs. 7/- + Rs. 3/-) per student for monitoring of entire examination procedure including the monitoring of the centre for Question paper and arrangement of distribution of Question papers.

All the Principals of Colleges / Higher Secondary Schools / Sr. Secondary School are requested to deposit @ Rs. 68/- (Rs. 65/- + Rs. 3/-) per student of their respective institutions to the Lead College (Karimganj College), Sribhumi on 15-18 December 2025 (From 11.00 AM to 3.30 PM). The payment may be made through any one of the following modes-


- a. Cheque, in favour of Principal, Lead College, Sribhumi.

- c. Cash Deposit to the Karimganj College cash counter, in case the above mentioned two options are not possible.
